- 95% reliability rate among program quality assessors
- Standards and Criteria developed by panels of early education leaders
- Accreditation process from start to finish guarantees fair and consistent evaluation



#4 NAEYC Accreditation is taking Quality to Scale in MN and other states!

Seamless QRIS entry, equitable pathways, accessible resources, and meaningful incentives are key.

#5 NAEYC Accreditation is an accelerated pathway in MN's QRIS

- MN accredited programs earn a 4-Star Parent Aware rating with minimal extra paperwork
- At least other 30 states and DC reference NAEYC accreditation in their QRISs
- States build on NAEYC's brand ownership, loyalty, trust, and familiarity that exist with ECE professionals
- Degree of alignment, reciprocity, and incentives varies



#6 NAEYC Accreditation is a Ready-to-Go Resource for Program Improvement

#9 NAEYC Accreditation Positively Impacts Child Outcomes

Minnesota

- Almost twice as many children in the accredited child care center sample were rated as “Proficient” or school ready as compared to the statewide 2003 Minnesota School Readiness Study.
- Children from lower income families performed the same as their higher income counterparts.

Boston Public Schools

- Programs engaged in the accreditation process scored more than a point higher on several quality measures than programs not engaged in the process.
- Preschool and kindergarten children in Boston Public Schools engaged in the NAEYC Accreditation process had significantly higher vocabulary score gains from fall to spring.

New Horizon Academy: Overview

At New Horizon Academy, 100 percent of our eligible programs in Minnesota are accredited by the National Association for the Education of Young Children (NAEYC), the recognized gold standard in the early education industry.

Our schools care for approximately 8,000 children from 6 weeks through the end of 4th grade.

We employ nearly 2,000 staff.

Our company includes:

- 60 New Horizon Academy centers in Minnesota
- 6 Kinderberry Hill Child Development Centers
- 4 centers in Idaho that are currently preparing to submit applications

This is an accomplishment we are confident no other child care provider of our size has ever achieved.

New Horizon in Minnesota has 62 nationally-accredited centers.
We also have four centers that have recently opened that are currently undergoing the process..
