Statutory Changes to Licensure Policy 2015 Session

* MN §122A.09 – Duties/License and Rules

- * Change to "Board adopted skills exam"
- Provision for candidate accommodations
- * Ability for the BOT to issue up to four limited licenses to attempt exams

* MN §122A.18 – Board to Issue Licenses

- Ability for the Board to grant limited licensure beyond 4 years at the request of a school district, when a candidate is struggling to pass skills testing
- Creation of "Provisional License" to be issued to any licensed teacher to teach outside of their licensure field to address a shortage (also in 122A.23)

Statutory Changes to Licensure Policy 2015 Session

* MN §122A.21 – Licensure Fees

- Licensure via Portfolio applications to be submitted to Educator Licensing
 - The BOT is to notify candidates of their determination within 90 days of submission
 - The BOT must advise candidates on how to successfully revise the portfolio to demonstrate required competencies
 - * Educator Licensing must approve or deny a portfolio within 60 days of resubmission

Statutory Changes to Licensure Policy 2015 Session

MN §122A.23 – Applicants Trained in Other States

- * Field Specific Methods and [Student Teaching or Experience] changed to Field specific Methods OR Student Teaching OR Experience
- * Board may issue a license based on experience and testing only
- * Applicants trained in other states may now have 4 years to pass exams and meet human relations requirements
- The Board of Teaching must work with designated authorities in adjoining states to establish interstate teacher licensure agreements under this section

Changes to Testing Requirements

- Immersion & World Language Teachers that are non-native English Speakers are not required to take the Skills Exam
- * The Board adopted ACT and SAT scores to be used to meet the skills exam requirement in 2014.
- * GRE, NES and (for licensed teachers from other states) Praxis will be added July 2016 to meet the skills exam requirement
- * Extra time for all candidates, candidate study materials and faculty support materials for remediation were requested within the 2015 RFP
- edTPA is now required for all candidates in MN teacher preparation programs. Minnesota candidates may present composite scores to be recognized for licensure in select states.

Previous Licensure Requirements In Statute

For the Issuance of a Full Professional license to a candidate licensed in another state

- * Training essentially equivalent to approved MN programs
- * Training specific to the instruction of English language learners
- * Training in scientifically based reading instruction
- * Training in multicultural education (Human Relations) including history, culture and language of Minnesota's American Indian population
- * MN Skills testing in Reading, Writing and Mathematics
- * MN Pedagogy Testing
- * MN Content (Subject area) Testing

Many candidates trained outside of MN were issued up to 3 - 1 year full time licenses to facilitate employment, while meeting these requirements.

Current Licensure Requirements In Statute

For the Issuance of a Full Professional license to a candidate licensed in another state:

- * Training essentially equivalent to approved MN Programs
- * Training specific to the instruction of English language learners
- * Training in scientifically based reading instruction
- * Training in multicultural education (Human Relations) Including history, culture and language of Minnesota's American Indian population
- * MN Skills testing in Reading, Writing and Mathematics
- * MN Pedagogy Testing
- MN Content (Subject area) Testing

Candidates trained outside of MN are able to be issued up to 4 - 1 year full time licenses to facilitate employment, while meeting these requirements.

MN Licensure Eligibility [Changes to MN §122A.23]

In order for out-of-state teacher candidates to be eligible for a Minnesota license, their teacher preparation programs must:

- Be regionally accredited (if offered by a college or university) and approved by the state in which the program is offered, qualifying the applicant for full licensure in that state.
- Be in a licensure field for which Minnesota has licenses and rules
- Be essentially equivalent in content and scope to approved Minnesota
 teacher preparation programs for the relevant licensure field

MN Licensure Eligibility [Changes to MN §122A.23]

Licensed teachers must evidence:

• Completion of supervised <u>student teaching</u>, or completion of a mentoring/induction program

<u>OR</u>

Two years <u>experience</u> in the subject and grade level of licensure requested

<u>OR</u>

• <u>Field specific methods</u> of teaching in the licensure field and at the licensure level

No longer required to evidence:

• A major or the equivalent, in the field of intended licensure.

Policy Changes by the Board of Teaching

- * A licensure committee of the Board has been established to review licensure appeals for those who have been denied licensure or have appealed their determination.
- Candidates are asked to submit any additional information that may not have been initially been provided or considered within the application process to meet identified deficiencies.
- * Per Board Resolution in April 2015, middle level licenses may be issued as a standalone license for those trained in other states.
- * Licensure Rules that are presenting barriers have been identified for specific fields. Rulemaking initiatives have begun for Developmental and Adaptive Phy.Ed.

Interstate Agreements

- Changes to legislation in 3 of 5 states impacted the ability to proceed with the draft agreement
- The Regional Comprehensive center in direct partnership with Wisconsin has agreed to provide technical support in drafting an agreement for all central states.

(MI, WI, MN, ND, SD, IA, NE, KS, MO, IL, OK)

 NASDTEC regional leadership negotiating agreed upon policies to facilitate teacher mobility

Rulemaking MN Rule 8710.0300-8710.0500 *RD 4369*

Goals:

- * Define criteria for Provisional License/Permission
- * Define similar licensure area and/or similar content field
- Define criteria for full professional licensure in Minnesota and the types of evidence that may be provided to demonstrate meeting criteria
- * Define "Restricted" license status and the means by which candidates can remove any restriction in content and scope
- Define the licensure via portfolio process and eligibility requirements
